#### **4. Eligibility Criteria & Document submission :**

The following is the minimum eligibility criteria for the Bidder to participate in the Bid “for Supply & Installation of Supermicro 4U Tower at IITB”,

- 4.1 Bidder should be OEM/Authorized Partner/service provider of the OEM. In case the tenderer is an Authorized Partner or Service Provider a valid Agency-ship/Dealership Certificate (MAF specific to this tender) to quote on behalf of OEM should also be enclosed along with the technical bid. **A document in support of this must be enclosed.**
- 4.2 OEM and bidder should have service and support office in Bangalore with atleast 3 Server support Engineers. **A self-certified document in support of this must be enclosed.**
- 4.3 The warranty provided by the bidder should have a back to back arrangement with the OEM.
- 4.4 ISO 9001 certified bidders preferred. **(Enclose copy if available.)**
- 4.5 The bidder shall provide the Registration number of the firm along with the valid GST number with PAN Number allotted by the competent authorities. **A self-certified document in support of this must be enclosed.**
- 4.6 The bidder must not be blacklisted by Central/State Government/Corporations in India.
- 4.7 The bidder must be responsible for supply, deploy and support the infrastructure.
- 4.8 Bidders can seek clarifications, raise technical / Financial queries etc. related to Tender by **22-12-2018** via email to **cao@iitb.ac.in**. The reply to clarifications sought or queries raised will be replied within 02 days and bidders may submit bids as prescribed by the due date the time. No clarifications in any other form will be provided.

#### **5. Other Terms and Conditions:**

- 5.1 IITB reserves the right to accept or reject any or all the Bids or cancel this process at any time without assigning any reason whatsoever.

- 5.2 The bidders, who do not meet the eligibility criteria; or do not submit all the necessary documents in support of the eligibility criteria; or do not submit documents that are complete and valid - shall be disqualified and they would not be invited for participating in commercial bidding (later stage)
- 5.3 The bid offer shall be valid up to 60 days after closing date of the Bid.
- 5.4 The bidder is expected to read all instructions, terms and conditions in the Bid document. Incomplete bids, bids received late, bids not conforming to the specifications and instructions contained herein, will be rejected summarily.
- 5.5 If a bid is not substantially responsive, it will be rejected by the Institute and may not subsequently be made responsive by the bidder by correction of the non-conformity.
- 5.6 Only those bidders whose Technical bids have been found substantially responsive would be informed by the Institute about their responsiveness.
- 5.7 Bidder whose technical bid is found to be acceptable and meeting the eligibility requirements as specified in this tender will be informed about the date and time of the opening of the price bid.
- 5.8 The Institute will award the contract to the successful bidder who has been determined to have qualified in the technical and commercial evaluation.
- 5.9 Any form of canvassing/influencing will attract rejection of bid submitted by the bidder and the Institute reserves the right to take such penal action (e.g. blacklisting the Bidder for the present and future etc.) as it deems fit. Notwithstanding anything contained above, the Institute reserves the right to reject all or any bid as recommended by the Bid Committee and is not bound to divulge any reason to the unsuccessful bidders.
- 5.10 In the event of dispute, Director, IITB shall be the sole arbitrator and his decision shall be final and binding on both parties.
